### Floor Open to the Public:

Mr. Michael O'Donnell asked when the Village was going to be dissolved and who would be taking over Code Enforcement when that happened. Mr. Salerno stated that if the Village dissolves it wouldn't be until March 2017 and at that time Rich Lapier would assume Code Enforcement for the Village. Mr. William Ball will remain Code Enforcement for the Village until that time.

#### **Department Head Reports:**

Edward Roberts-Building & Grounds Superintendent: They have been working on road side garbage. Next week they will begin work at the Campsite with the inmates; weather permitting.

Art Morgan-Water & Sewer Superintendent: They picked up the two new trucks. Surplused two trucks to the Highway Garage.

Richard LaPier- Building Codes: No building permits were issued in February. Issued 3 notices of complaint. Attended code update training in Lake Placid. Mr. Lapier reported that the new code if approved by the Department of State will take effect June 28, 2016. It will be going with International Code with NY supplement of over 100 pages of changes to the codes. Mr. Anderson asked if these changes would make it more expensive to build and Mr. Lapier said no, should remain the same.

There was no Police Report.

#### **Town Board Reports:**

Councilman Anderson reported that the Youth Commission just met and he is happy to announce they have three candidates for the Director, Co-Director and Activities Coordinator positions. Valerie Wykes has applied for the Director position, she will not be 21 years of age until August, they will get an immediate exemption from the state and there should be no problem.

Supervisor Scozzafava arrived at 6:10PM.

Councilwoman Carpenter reported that she has been looking into a camera for the Campsite. Both systems will require the internet unless we go with a closed circuit system. Councilman Garrison suggested we get RFP's for a system. Supervisor Scozzafava reported that the Highway Garage and the Water & Sewer Department need security systems as well.

Councilman Garrison had nothing to report.

Councilman Salerno reported that the Campsite letters have gone out. Next week Building & Grounds along with the inmates will begin cleaning up the Campsite, weather permitting.

#### Supervisor's Report:

Supervisor Scozzafava reported that he was in contact with the Department of Health regarding his concerns with the drinking water, given all the problems in Flint and Hoosick Falls. He wanted to make sure we were adequately testing and we are. We have no high levels. Eventually there will be stricter testing.

The Town received partial payment from the Department of State in the amount of \$213,477.00 for the Campsite Shoreline Erosion Project. We will put this towards the \$500,000 bond.

The Supervisor, Art Morgan-Water & Sewer Superintendent and the Engineers all met to discuss infrastructure repair that needs to be done. Main Street in Witherbee and also Lamos Lane in Witherbee are a priority. There is still money left over from the Water District #4 project. We are hoping to use that for a booster pump on plank road and replace the pressure reducer on Tarbell Hill.

The Titus Road Pump Station is complete. The Town is taking out the \$80,000 bond because if we don't and use fund balance we won't be eligible for any grant money.

Councilman Salerno asked if the household income for the Witherbee project could be lowered. The Supervisor stated that the medium income has to be below 51%.

The Supervisor said that if the Village dissolves, Water District #3 would be added to the new water district in the Village. The cost to replace the 2 inch main in Water District #3 is probably going to be around \$100,000. If wells were put in, in Water District #3, the town would incur the initial cost and then it would be the responsibility of the homeowner.
