The Town of Moriah Town Board held their Regular Town Board Meeting on Thursday, November 9, 2017 at 6:00pm at the Town of Moriah Court House, 42 Park Place, Port Henry, New York.

Supervisor Scozzafava opened the meeting at 6:00pm.

Supervisor Scozzafava read the legal notice for the Public Hearing that was held prior to the Board Meeting.

RESOLVED that the Town of Moriah Town Board approve the minutes from the previous meeting.

Floor open to the public:

Cathy Sprague from the Chamber reported that Small Business Saturday will be November 25, 2017, they have 15 businesses participating. They will be offering free coffee and 10%-20% off. This will be in the paper. The Holiday Train will be here Monday, November 27, 2017 at 4:45. The lighting of the Memory Tree will be Friday, December 1, 2017 at the Bandstand between 4:30pm-8:00pm with the Fire Truck parade. The Supervisor thanked Cathy and her crew for decorating the train, and also thanked Cathy for everything that she does. Councilwoman Carpenter reported that on Sunday, December 10, 2017 there will be a candle lighting at 7:00pm at the Angel of Hope.

Department Head Reports:

Rich Lapier-Building Codes: Issued 4 building permits for the month of October. Inspected 2 units for certificates of occupancy. Dollar General is almost complete; a few miscellaneous items are left to be completed. Cathy Sprague reported that Dollar General told her they would be opening the middle of December.

Jamie Wilson-Highway Superintendent: They have been busy getting the plow trucks ready for snow. Hauled in all the sand. New drivers have been learning the plow routes. Mr. Wilson wanted to remind everyone that broken down vehicles need to be moved out of the way of the plows. There is still discussion on roads in Port Henry that were "maintained"; paved, pot holes fixed, etc., by the Village of Port Henry, the Town will have to continue to plow these. If these roads were just plowed; the Town will not continue to do so. The Town is in the process of determining if they are Town Highways or not. The Supervisor stated it would be illegal to continue maintaining/plowing these roads and it would open up a can of worms. Erik Wilhelmson expressed concern about his road, he said it is better but still needs work and Mr. Wilson stated they are doing the best they can. The Supervisor asked Mr. Wilson what the issue was and he stated where they dug out big rocks, little rocks are working their way to the surface.

Chip Perry-WWTP: Excused.

Ed Roberts-Building & Grounds: Excused.

Art Morgan-Water & Sewer Superintendent: Excused

Town Board Report's:

Councilman Anderson: Nothing to report. Supervisor Scozzafava told him good luck to the boys football team and the girl's soccer team.

Councilwoman Carpenter: Read police report: Handled 141 call for service. 11 Violations: 1 Harassment 2nd degree, 10-permitting chickens to run at large. 2 Misdemeanors: 1-aggravated unlicensed operation of a motor vehicle 3rd degree, 1-attempted assault in the 3rd degree. 0 Felonies. Issued 19 Traffic Tickets. Handled 7 traffic accidents. Conducted 14 pistol permit background investigations. Rich Lapier stated he is "gaining" on the chicken problem.

Councilwoman Carpenter reported that the Town cannot go to bid again on the Iron Center doors until we get approval from the State Historic Preservation Office. They have a meeting on Wednesday, November 15, 2017 with Fred Keil, the architect. We need to move forward with the grant. There is a resolution later on regarding Phase 2 of the Waterfront Strategic Plan.

Councilman Garrison: Nothing to report.

Councilman Salerno: Reported that Becky is still working on the campsite numbers, he will have them for the next meeting. It was a good season. There are five campers at Bulwagga Bay Campsite that did not comply with the rules and regulations regarding cleaning off their sites at the end of the season, Councilman Salerno will call Wayne & Ruth regarding this. The Supervisor stated they should not have gotten back their \$50.00 deposit.

Councilman Salerno stated that Moriah Shock and the inmates have been a great help. The boiler at the Train Station is not working very well. The Supervisor stated that Jim Brooks has looked at it, he tried to seal it. Councilman Salerno asked about getting a new boiler, the Supervisor will have the Town Clerk look into the insurance claim on this one. Councilman Salerno thinks there should be a 20 year warranty on this one.

Supervisor's Report:

On November 15, 2017 at the North Country SBDC in Plattsburgh there will be a Small Business Workshop for Veterans.

The Supervisor received an email from Linda Smyth regarding volunteers to raise money for an Iron Ore Miner statue. He thinks this is a great idea. They are meeting again on the 14th. Cathy Sprague stated they have opened a special checking account for the funds raised. They have somebody from every hamlet on the committee. Erik Wilhelmson asked if it would be full size and are they worried about vandalism. The Supervisor stated it will be full size and he doesn't feel we have to worry about vandalism.

The Supervisor received an email from Jim Besha regarding the Hydro Project. FERK is requesting more information regarding any marble quarry near the old green change house, as far as the Supervisor knows there isn't one and he has forwarded all the information he has to them.

The Supervisor and Chip Perry met with the engineers regarding Manhole 13 and the slope failure on this project. CP Rail wants it more stabilized. The Town inherited this project when the Village of Port Henry dissolved and now everyone is saying that the town is responsible. The Supervisor has spoken to retired New York State workers who will sign affidavits regarding the slope failure problem and that it has been like that for years.
