We need to continue improving the conditions of all roads and roadways, the sidewalks and the operations of maintaining them. It is a tough job for the village crew when there are many emergencies. TRUSTEES MATTHEW BRASSARD & STALEY RICH REPORT TO THE VILLAGE

Although both Mr. Brassard and Mrs. Rich are running uncontested in the up-coming election this coming March 18th, they wished to let residents know their reasons for running and some of the projects they have worked on, projects in the works now and future goals.

Matthew Brassard

I am running again because I really enjoy what I do. I like interactions with my fellow village citizens on a daily basis. I also want to be able to be a part of the continued growth and infrastructure rebuilding in the Village.

There are a few more important things I would like to see done over the next two years if I'm reelected. The first is to continue to look for and apply for infrastructure grants; much the Village infrastructure is still in very bad shape, and needs to be repaired.

The second is to try and replace a good amount of the sidewalks in the Village. The Village of Saranac Lake took a bond out a few years ago to replace a lot of the sidewalks there, which is an idea I think would work well for our Village. You can get all the sidewalks you want replaced done at one

shot, with the cost spread over many years.

I feel the Village has made great improvements in a few areas, one, having the correct equipment to do the required job. We have purchased a new front end loader and some attachments for the village's equipment, to save time and money in the long run. We have been pretty successful in just the last two years is getting grants. We secured 700,000 dollars for the complete reconstruction and infrastructure upgrades to Elizabeth

Street, secured a main street grant for property owners on Main Street which was a 50/50 matching grant. (Example: The updating of the old Sagan building)

I feel it's very important we start to upgrade the Village campground. Particularly, the bathrooms need upgrading. We need to really think about redesigning the sites and come up with an actual square footage per size, this will allow the campground to add a few more sites and generate more revenue as the campground is the second highest revenue coming into the village behind the taxes we collect.

Serving two terms on the Port Henry Village Board of Trustees has been an incredible amount of work. Most people do not understand that the basic running of a municipality has changed drastically in the last decade. Status quo is gone and government boards are at the mercy of state mandates and highly competitive state funds. Port Henry, in particular, has struggled for decades trying to revive a community and business economy which collapsed with the closing of the mines.

I decided to run again for re-election because this current board has worked very well together. We recognize and are working to make Port Henry a community that is competitive for both state money and private development. In order to do this, much time and effort has been focused on modernizing outdated laws and procedures that no longer work for us. We have spent an enormous amount of time researching and investigating what areas in the village are our strengths, and what are our weaknesses. In that process we discovered we lacked long term planning and credible statistics to use for successful grant writing. These items are not glamorous headlines that make the residents go - WOW! Instead they are tedious housekeeping items we have had to work on for Port Henry to enter a very competitive marketplace for economic growth and state support.

Port Henry has moved forward with a long term plan in place that addresses infrastructure, housing, recreation and waterfront, aesthetics, community, and preserving our historical resources. Please feel free to stop by the Village office to look at it. The Comprehensive Plan capitalizes on our villages strengths and identifies the areas we will concentrate on in the future. This plan is a roadmap to our future and puts Port Henry on equal footing with other communities competing for the same opportunities. New York State wants a plan before it will invest in a community. They want to know where we are going and how we plan on getting there. Developers and Corporations demand and expect written regulations so they can know upfront what will be allowed and expected within a community so they can plan financially to invest in a community. These expectations are not options anymore for any community that wants growth. Together as a board we have got these done and will capitalize on them to move Port Henry forward.

With some major milestones reached I have high hopes for my next term. I believe you will see improvements in infrastructure, on the waterfront area, and a much improved streetscape in the Downtown area. With our homework done and a plan in place, expect to see Port Henry actively compete for improvements and processes that will complement and enhance our community.

NEW NEWS FROM THE MAYOR'S DESK

Jim Casey from the State Finance Department called saying the final reimbursement payment from FEMA of \$188,285.00 had been processed and the Village would be receiving it in seven to

fourteen business days!!! Today, Friday the 20th, the Board met with Nicole Allen of Labarge Agency concerning zoning which is a necessary step toward attracting businesses to Port Henry, as Trustee Staley Rich noted in her report.

Not "new news" but something the Mayor wished to encourage people to remember to do in this unusually cold winter – leave your facets open so there is a strong trickle of water at least over night and in any area of the house that has seemed prone to freezing up. Fact Finder's editor is old enough to remember that this was the norm in winter, even in Texas.

SETTING THE RECORD STRAIGHT - FACTUALLY

In a small village, because it is small and because everyone is connected, in some way, by family or friends; rumor-telephone exists at a high level. There are at least two reasons the rumor-mill grinds so speedily and so fine - trust, because it is coming from a family member or a close friend it can't be lie and it is too time-consuming to google-around searching for the facts of the matter. Here we depart from the main road to explore a side-path, the distinction between the two words – fact and truth. Fact can be stated as an event or the existence of anything visible or, in some way, tangible. Truth can be expressed as the subjective form of fact, a perception of a fact. Each person experiencing a fact will perceive it differently, sometimes quite differently, as testimonies taken at the scene of a crime seem to prove.

All of the above being said, Fact Finder would like to provide the facts concerning a rumor that seems to continue its life on the rumor-telephone. December, 2014 at an open meeting, the Village Board awarded eight employees COLA (Cost Of Living Adjustment) checks which raised the hackles on many a resident's neck and speedily ran the rumor gauntlet. These were once-only benefits which were already in the budget under staff salaries and costing no additional monies to the tax payers. Taxes were withheld and they are pension reportable. **None of these checks were for anyone on the Board!** To be perfectly certain that these checks were unassailably legal, the Board checked with the New York Conference of Mayors, the Comptroller's Office and the firm that does the yearly audit for the village, all gave their nod of approval. Fact Finder does not expect that all residents, even a majority, will read this and learn the facts, but if any readers do hear others who are not on the page of these facts, please, help them understand. Our village mayor and trustees are a group of people who are trustworthy, if only because they live here too. Whatever choices they make for the village, they are affected by these choices the same as everyone else in the village

GOOD NEWS

Fact Finder truly needed to know how the <u>Fashion Corner</u> was doing after its loss and how the <u>"Baker"y</u> in Mineville has been prospering after an amazing opening a few weeks ago. I visited both on Friday the 20th and was very relieved and happy to report good news from each visit.

I have been watching the windows of the **Fashion Corner** and have seen no change in the beauty of the weekly changes in dresses. On stepping in Friday, I was greeted with the same racks filled with the usual gorgeous array of dresses and with the same feeling of being in a flower garden of every color possible. Candy Baker was serving a customer so Allan stepped out to welcome whomever had come in. This was the only change but the atmosphere had not changed and I began asking Allan how things were going. He said it was still a full-service store and that they had been receiving new dresses regularly, in fact two new wedding gowns had arrived the day before and a box of prom dresses which they had not yet opened. If anyone needed comforting proof of Allan's commitment, this is it. Once, Natalie told me that when these gowns were bought, they were bought, no returns, they were Fashion Corner's and had to be sold. I asked Allan if they ever had sales and he said, "Yes." The last one was in December and the next sale has not, as yet, been planned. I invited him to be sure and let Fact Finder know when the next sale was due and this news would appear in the Fact Finder issue closest to the sale date.

The "Baker"y in Mineville, opposite the graveyard, was just about as empty of goodies at 3 pm when I dropped in as when I first visited it on its opening several weeks ago; this was an encouraging sign as closing is around 4 pm. When I asked how business has been Laura said that it has been so much better than she had expected, sometimes even a bit overwhelming, but always welcome. I cringed at her answer to my question as to when she had to get up; her day usually begins at 3 am! Customers came in and took twelve coconut macaroons and some chocolate chip cookies from the small display of remaining goodies. I was particularly concerned about those macaroons; I wanted to try some (they did not take them all!)

Laura and her two-and-a-half year old son live above the shop. I now have a new love in my life, Barrett, Laura's son. He react's and speaks like a five year old and is an absolute charmer. When I was leaving he kept saying something we couldn't at first identify, finally, we realized he was saying softly "I'm a peanut." Laura didn't know where that came from as he had never said it before.

Later, I learned interesting history of the building itself. In 1876 it was a hotel probably with a bar, as it was a bar, called Club Restaurant (which did not allow women) before Prohibition and was the first bar in Essex Co. to reopen when Prohibition was repealed. Another rather disturbing but fascinating story is that during Prohibition moonshine was peddled from the "honey wagon" as it went around cleaning the outhouses; as I said, a rather disturbing mental picture but a fascinating anecdote.

For a good many years the bar was run like a true English pub. There was a dart board where many people played darts and in the summer games of horse shoes were played outside in back of the bar. Things began changing in 1992 when DWI laws were put in place. Now, the area has this truly wonderful new drawing card – the "*Baker"y*.

Laura suggests that people would be wise to place special orders such as doughnuts (Laura said that Donut Days were going very well) or large orders 24 hours in advance and 48 hours for specially designed cakes. Also, she has all the ingredients to bake gluten-free, which would need to be ordered ahead as other special orders. She said how grateful she is for all the support she has received and to please thank everyone. The phone number is <u>518-942-6549</u>. It is Fact Finder's choice to put in the "518" just in case people from Vermont or New Hampshire happen to want fresh, hot doughnuts on their travels.
