The Supervisor called the meeting to order at 6:00pm by saluting the flag.

## **Department Head Reports:**

Jamie Wilson, Highway Supt., reported that all applications for funding will be submitted tomorrow for the DHIPS projects; we did very well.

The Water & Sewer pick-up arrived; still waiting for the other truck. The Board and Jamie discussed removing the radios or waiting until the new ones are in and paying only one time to set up the radios. Mr. Wilson asked that highway get the old truck to use as back-up in case they have a truck down. The Supervisor stated the reason we are getting rid of the truck is that it is nickel & diming us to death. Mr. LaPier asked that the campsite have the truck to replace the old blue one that has no floor boards. The Board discussed the option to use the truck for the honey wagon. Mr. Wilson will get the information together as to what we can sell as surplus.

Mr. Wilson thanked all the department heads for what they do. He wants people to know what they do and that they work within their budgets. He wished everyone a Happy Holiday and to drive safe. The Supervisor stated that all departments are great at staying within budget.

Richard LaPier, Building & Codes Inspector, reported that he issued two building permits in November and handled two notices of complaint.

### **Town Board Committee Reports:**

Councilman Anderson gave the following police report. The Police Department handled 168 calls for service in November of which there were no violation arrests, made four misdemeanor arrests, 0 felony arrests, issued 17 traffic tickets and handled nine traffic accidents. Mr. Scozzafava stated that he spoke to Officer Stahl who spoke to Officer Brassard about having him and Ed Roberts go street by street and get the pole numbers where the street lights are out. Just wanted the Board and public to be aware of what they are doing.

Councilman Anderson reported that the Youth Commission is looking for someone to run the youth ski club. If anyone is interested they can leave a message at the Town Hall for him or call the school.

Mr. Scozzafava reported that the Viking Ship for the playground has been ordered. They either had to order it now or lose the money wasn't spent by the end of the year.

Councilwoman Carpenter had nothing to report yet. She did want people to know that there are ornaments for sale to help fund the Angel of Hope Project. They have located a contractor to level and grade the land for the Angel on the space they have chosen. January 25<sup>th</sup> there will be a bowling tournament and they plan on a dinner dance at the VFW; she is looking for volunteers if anyone is interested there is a meeting January 2<sup>nd</sup> at 6:30 at her shop.

Councilman Garrison reported there will be an Economic Development meeting January 15<sup>th</sup> at 6 PM. The Village received a main street grant which is a matching grant; this is a huge deal. The businesses that take the grant have to match the amount they take; they had to have written commitments from businesses in order to apply for the grant. Mr. Scozzafava stated that the Town received \$31,000 for a waste water study; primary issues are in the Village.

Councilman Salerno reported that the rates at the campsite were the same last year as the year before. He asked the Board if they thought the rates should be raised this year. The Board discussed this and decided for what we have the rates should stay the same. The Board decided they should do some homework on raising rates before doing so. Mr. Garrison stated that governments shouldn't be running business and that is what we are doing. The Board discussed leasing vs. selling the campsite; the Supervisor stated that a referendum is needed to sell. We will keep trying to market the campsite.

Councilman Salerno reported that we took in \$11,375.40 for the scrap metal at the transfer station. Mr. Wilson stated that they did a good job cleaning up with the magnet.

# Supervisor's Report:

- Received notification from NYS Real Property that they reviewed the 2013 Aid for Cyclical Aid application for the Town. We did not meet one of the critical standards, reappraisal, and we are not eligible for State assistance on the 2013 assessment roll. This requires a field visit to each piece of property and this wasn't done so we don't get the money. This money was anticipated revenue now we have a whole in the budget.
- Had asked to use the money that was left (\$185,000) from the Water District #4 grant to buy a backhoe for W&S Dept., but was told we can't do that. The money goes back into the fund to be used on another project in other communities.
- Received a call that we received a \$6,000 grant for speed signs for in front of the school.
- Received inspection report from Ag & Markets on the temporary kennel we have set up; all is in order. We need to up-date the animal control law; we are dealing with everything now, the laws are antiquated.
- Gas was \$2.98 through state contract and we paid \$2.90 through Citgo in November.
- Had an audit by the Comptroller for the tax cap for the last three years. We're good, we met it for the last three years. Under the governor's new proposal, if it goes through he wants to award incentives for the tons that meet the tax cap and the state will make up the difference.
- We had been requested to reduce the speed limit on the Moriah Road; the Sheriff's tracked the traffic and the majority is going 55mph. They will increase radar there. It does not warrant changing the speed limit.
- If we do anything with the Cold War Exemption it has to be done by January or February.
