Digger Laing presented the Board with a verbal report on the DPW for the month of February 2016 as follows:

- Wire at beach removed and replaced

- Public Protection Classification (PPC) Summary Report has been completed by the Insurance Services Office, Inc. and submitted to the Village of Port Henry on February 26th, 2016: Total Credit 58.46 out of 105.50. The resulting community classification is Class 05/5Y.

PUBLIC COMMENT PERIOD

Sandra Lovell read aloud a handout (attached). Trustee McDonough indicated that the handout should be brought forth at the Public Hearing on April 5, 2016 at 7:00 pm at the Knights of Columbus. Ms. Lovell indicated that she would do so and will also publish such in the paper before April 5th.

Amanda Lovell noticed the Village made repairs to the beach after the recent flooding of Mill Creek. If dissolution is transpiring, why is the Village making these repairs? Trustee McDonough indicated that the Village is obligated to make necessary repairs to Village property and continue normal operations through the proposed date of dissolution; March 31, 2017.

Sandra Lovell noticed that there was a lot of sand recently replaced at the beach. Mr. Laing indicated that there was no additional sand hauled in, the DPW is doing what is normally done in preparation of the campground and beach opening for the season.

The pump station has been relocated so that it is not on Burlingame's property.

Update on Rice Lane Project - a preliminary meeting was held two weeks ago with the Laberge Group. The surveyors marked out areas on Rice Lane and will get back to the Village soon.
