#### NEWS RECAP

Voting Day has come and gone and votes were cast by **361** voters out of a possible **596**, with **19** votes favoring dissolving the Village of Port Henry. First and foremost the Village or Port Henry residents should be commended on the voting turnout. Over half of the possible voters responded to their call to civil duty. Would the vote have been different if those remaining **235** votes been cast, quite possibly not, but the result would have held no lingering question mark, as it does when there are un-cast votes. Note that until the Dissolution Plan has been voted on, and either passed or not passed, life will continue as usual for both Town and Village residents. The Fact Finder's issue schedule can be unfortunate when it comes to breaking-news, therefore it became necessary to issue an "EXTRA" to solve this problem. For those who may not as yet have read it, a reprint follows:

#### EXTRA - FACT FINDER - EXTRA

Over five years ago, Fact Finder entered the world a one-page "question mark," an experiment, and in that time this Editor has never felt it truly necessary to put out an "extra" issue.

In the two nights and one day since the vote on dissolution was decided, I have realized many possible facts which caused the need for a second try at dissolution. First and foremost the first effort, obviously, did not solve the problems which had called it forth in the first place. The Village retained its place among the villages of New York State and life for the ordinary residents of both Village and Town continued pretty much the same with both Town and Village Boards trying to serve their people with the best decisions they could make.

The second realization was that each group, pro and con, wanted the same thing for the residents of both municipalities – a better life. So how had the first dissolution effort failed, because it  $\underline{did}$  fail and life went on as usual.

This editor wonders what would have happened if the dissolution process had been put in motion at that time. Where would Village and Town be today? Of course, no one knows, no one should even waste time on "what iffing." However, there are two useful questions: why was the "process" of dissolution not begun previously and why has it begun now. The answer to both is the same: there is an almost equal divide between village resident thinking on what is best for village life and growth. That divisiveness will continue until one group convinces the majority of the other group that their way is, provably, the path to the best future for the village.

Now the hard, *really* hard, part begins. This will fall on a committee, the Planning Board Committee. This committee will succeed only if the people on it are willing to risk leaving their comfort zones of not stepping on other people's toes, of keeping their most real thoughts private, of being fearful they may learn something which will change their minds, their thinking, of searching diligently and presenting only facts to support their stance. They must be willing and able to debate, to argue, absolutely non-personally but as heatedly as is necessary, to support their research. If this happens, the plan will either pass or not pass, but this will result in two communities, truly united and happy, working toward the same goal, a good life for everyone.

Another "Re-cap", as promised in the last issue of Fact Finder. The figures and facts from the Port Henry Fire Department as reported by Fire Chief Jim Hughes at the last dissolution informational meeting of October 21<sup>st</sup> follows:

### What have you been getting?

- Fire protection since 1874 or 141 years of dedicated service.
- The largest, oldest, most diverse, all volunteer fire department in town with 54 members and growing.
- Fire Suppression, Accident Victim Extrication, Surface Ice Rescue, Boat/ Water Rescue, and Dive Rescue capabilities.
- Prompt Fire Response / Manpower: In 2014, the average response time was 4.35 minutes with an average of 7.3 Firefighters responding per call. For 2015, to date 55 calls, **3.14 minute** *response time* with 8.9 Firefighters responding per call.
- (1) NYS Licensed Practical Nurse; (2) NYS Certified First Responders and several Basic First Aid/CPR/AED certified Firefighters; (18) Surface Ice Rescue Technicians; (16) Jaws of Life Technicians; (1) HAZ MAT Technician, (5) NAUI Certified SCUBA Divers and (3) Firefighters with specialized fire suppression skills in crude oil derailments.

• Responded to (89) calls in 2014, (63) in 2013, (74) in 2012, (103) in 2011 which included Structure Fires, Mutual Aid to neighboring communities, Ice / Water / Dive Rescues, Search & Rescue, Accident Victim Extrications, Car Fires, EMS Lift Assists, EMS Driver Requests, and Safety & Well Being checks on our elderly?

- Sponsors an annual \$500 Academic Scholarship (Ray McCabe Memorial Scholarship) to a college bound Moriah Central School Senior who has excelled in Science every June?
- Donates \$500-\$1000 annually to the Town of Moriah Food Pantry?
- Successfully achieved, since 1994, over **\$276,382** in various grants and awards for equipment and tool purchases at no cost to the taxpayers?
- In conjunction with our Auxiliary, at Christmas, annually distributes over \$1000 in candy & toys to needy children and families within the village?

Although it is after intervening events, I would like for some of his words and thoughts to be printed in the Fact Finder.

"In closing I would like to add a few comments of my own..." He said that he and "Tommy" had known each other all their lives and, whatever happened, they would continue to be friends. Mayor Guerin pointed out that this past January the Town had resolved that the Village should be dissolved; he asked did they have a plan. He said he did not think they did. He ended by saying he "would appreciate it if we would stay a Village."
