The Supervisor stated that we have gotten in half of the stimulus money; still waiting to hear exactly what it can be spent on. We know it has to be used for water and sewer but nothing else is concrete yet. We cannot reduce taxes with it. Councilman Salerno stated it would be good to use some of it for water and sewer for the cabins at the campsites. The Supervisor stated we are waiting on clarification of "economic development" from the state. We have until the end of 2024; we need to put a lot of thought in to it.

The Supervisor stated he met with Jack Mudge regarding the installation of the charging stations in the parking lot next to the Post Office. Mr. Mudge has no issue with it. They will be able to accommodate 6 vehicles. Mr. Mudge did suggest some improvements to the parking lot; paving and striping; the Supervisor stated he agrees and maybe we can use some stimulus money to do it. Apex has started the work. Councilman Salerno asked if there would be a premium to charge and the Supervisor stated the first few weeks will be free; then it will increase to \$1.00 and then \$5.00; should give 3-4 hour's sufficient charge. The Supervisor stated we need to revise the agreement with Mountain Lake Services.

Councilman Salerno asked the Supervisor about the Building & Grounds Supervisor applications. The Supervisor stated we received 13 applications. He emailed the Town Board; need a committee to go over applications and pick the most qualified. Councilman Anderson feels it should be the Supervisor and one Councilman. Councilman Salerno asked if the committee would then bring their recommendations to the Board. The Supervisor said yes; narrow it down to 3 and then the whole Board could interview top 3 at a special board meeting.

Councilman Anderson stated we have not spent any money on the youth program the past 2 years due to COVID; at the Board meeting next week he is going to request money for transportation to Whiteface so he can start a youth ski program. The Supervisor stated he thinks that is a great idea and the Board needs to approve it.
