The Town of Moriah Town Board held their Regular Town Board Meeting on Thursday, August 11, 2022 at 6:00pm at the Town of Moriah Court House, 42 Park Place, Port Henry, NY.

The Supervisor stated we started doing meetings live on Facebook due to COVID, we will continue to do this but the Supervisor stated he will not interrupt the meeting for questions; he will address comments at a later date; the Board was in agreement with this.

The Supervisor reported on the accident on Main Street. He stated this accident could have been catastrophic. He commends the young man driving; there were mechanical issues. He was able to turn the truck enough so he didn't go in to any buildings; he did everything he could; he did a great job. The Supervisor stated that by the grace of God nobody was in the area at that moment. The Supervisor stated he received numerous calls and comments. The Town did a study in 2020. When the Village dissolved in 2017 the Town took down the truck route signs and left it up to the truck driver. The Supervisor stated that after being pressured by one resident the Town did a truck route study in 2020 that cost the Town \$4,600 by Barton & Lejudice; they recommended Broad Street as the truck route; 2<sup>nd</sup> choice would be Church Street. The Supervisor stated that both areas have issues. So in 2020 the Town designated Broad Street as the truck route on recommendation from Barton & Lejudice. The Supervisor stated accidents do happen.

Councilman Gilbo stated he read the study and it stated Broad Street was acceptable because of the slope, College Street was not. The Supervisor stated he, Jamie Wilson and the County all spoke to the State this morning and they don't want anything to do with it. The Supervisor stated the Town has done extensive research on this. He stated that very few Town's establish a truck route due to liability reasons. He stated there are alternatives; go over Pilfishire Road, Edgemont Road or down Moriah Road; he stated there is not a perfect solution.

Councilman Brassard stated that Broad Street is the best route per truck drivers. Jamie Wilson stated drivers are divided on which is the best route. The Supervisor stated we are telling them to go down Broad Street. Jamie Wilson stated the driver said he couldn't have made either turn. Joel Zelinski asked if there were steep grade or low gear signs at the top. The Supervisor said yes. The Supervisor stated the Town Board has no control over mechanical failure. Patricia Montgomery asked what the truck volume was on Broad Street, Mr. Wilson stated he did not have that information with him but he believes it is between 5,000 - 6,000 cars a day. The Supervisor stated that Plank Road gets 5,000 cars a day;  $2^{nd}$  heaviest in Essex County. The Supervisor stated that 9N & 22 is the main corridor in Essex County.

Councilman Anderson asked if we can end requirement and leave it open to the driver. The Supervisor said yes and we could put up flashing lights at the top of the hill.

Katrinka Tromblee asked if the Town could make a truck run off on Grove Street and Councilman Brassard stated a run off is an option. The Supervisor stated there are apps for truck drivers regarding routes. Jamie Wilson stated that a truck run off is not the issue; if you can't make the turn you can't make the turn.

Ron Sargent asked what the speed limit is and the Supervisor stated 30mph. Patricia Montgomery stated that Edgemont Road should not be a truck route, it is a residential area. The Supervisor stated he feels flashing lights, signage and "recommend" the route might help; let the drivers decide for themselves. He stated we need input from truck drivers. Councilman Gilbo stated he was in agreement with "recommended" route. Councilman Brassard wants signage put up also. Councilman Gilbo stated it is a densely populated area, we will need to look at alternative routes such as Pilfishire Road and Moriah Road. The Supervisor stated it is a County

road; the safety of the community is this Board's top priority; they are trying to do it the right thing.

**Special Guest-Vicki Trudeau:** The Supervisor asked her to come to the September meeting to give her ample time.

### Floor Open to the Public:

Joel Zelinski and Ron Sargent from the Moriah Snowmobile Club were in attendance. Joel Zelinski stated that the snowmobile races in February were a success. Next year it is going to be a 2-day event. The Club that sponsors the event were very happy with the race. Mr. Zelinski stated that Port Henry Beach is their first choice for them with Bulwagga Bay as an alternate; depending on ice conditions. He stated the parking worked out ok; may have to plow more of the beach. The Supervisor stated we could get a County van to transport from the boat launch. The dates will be February 18<sup>th</sup> and 19<sup>th</sup>. The Supervisor stated that same as last year the Town will pay for the insurance for the first day and the club is responsible for the 2<sup>nd</sup> day. Joel Zelinski stated in order to do this they would have to give up all the gate money and the Supervisor stated that is up to the Snowmobile Club. Councilman Anderson asked if they had any sponsors and Mr. Zelinski said Manfred Construction. The Supervisor thanked Mr. Zelinski.

Andrea Anesi reported on Champ Day. She stated it was successful; a lot of positive feedback. Movie night at Bulwagga Bay was fun and they had a good turnout. Approximately 500 people attended Champ Day; the heat was brutal. Ms. Anesi stated that one vendor loved the waterfront so much they are going to try and get a seasonal site next year. Ms. Anesi thanked the Town Board, Councilman Brassard, both campground managers; she stated it was wonderful working together. The Supervisor thanked Ms. Anesi for all that she does for Champ Day.

Patricia Montgomery reported on Moriah Music Fest. Equipment rental is \$2,700. It is September 10, 2022 from 5pm - 8pm at Port Henry Beach. Councilman Brassard stated they wanted it on the waterfront instead of the bandstand. Ms. Montgomery stated they have 3 bands and some food vendors.

## **Department Head/Town Board Reports:**

Rich Lapier-Building Codes: Issued 7 building permits for the month of July; he has a subdivision application for Leslie Cunningham for Plank Road in Mineville and he recommends approval.

Jamie Wilson-Highway Superintendent: Sidewalks in Port Henry are completed, will be working on some in Moriah, for this year sidewalks in Port Henry are done. They have been doing roadside mowing & brush. They have been helping out Westport, Crown Point, Keene and the County also; Towns are working together. The Supervisor thanked Mr. Wilson and crew for the work on the field in Port Henry where the old school was; County gave the Town 4 lots; will turn in to a community field for little league, baseball, etc. Mr. Wilson stated should get power in there. The Supervisor stated he has heard complaints that this property was taken off the tax roll. The Supervisor stated this property has sat there; old school burnt down; he feels this property

will be an asset to the community. Mr. Wilson addressed the Board regarding a new excavator. He would like to use CHIPS money that he has been saving to pay for it. The Supervisor explained CHIPS money. The Supervisor stated CHIPS money is over \$200,000 and the Mr. Wilson said yes. Councilman Anderson asked Mr. Wilson if he heeded Board approval to act on the excavator quickly and Mr. Wilson said yes. The Supervisor asked Mr. Wilson if this is something that would get used constantly and Mr. Wilson said yes. The Board was in agreement with this.

Councilman Brassard reported the Campgrounds are going good. Champ Day was a success. He has been meeting with Patricia Montgomery regarding Moriah Music Fest.

Discussion: The Supervisor stated we will set up a reserve for this money.

Councilman Anderson reported the summer program came and went. After 2 years it was good to have the program back. He thanked everyone and also CV Tech for allowing us to have it there. Moriah Central School provided the transportation. Hopefully it will be back at MCS next summer. The first 2 weeks of the program they averaged 65 kids a day and the last 2 weeks of the program they averaged 75-80 kids.

Councilman Gilbo is still trying to find someone to do a grant analysis.

Councilman Anderson asked about the solar field on Tarbell Hill, stand still? The Supervisor stated they can't work on it April – October because of the bats. Councilman Anderson asked if it was still a go and the Supervisor said yes.

### **Supervisor's Report:**

The Supervisor stated that the Town does own the old water tower on the end of Spring Street. It needs to be fenced. Still waiting on a quote from Middlebury Fencing. Posted signs have been ordered.

The Board of Supervisors were approached by Phoenix Tailings; they want to test the pile at Barton Hill for rare earths; worth a lot of money right now. The tailings are worth more than the ore.

The Supervisor stated he toured Moriah Shock 3 weeks ago, he was dismayed at what he saw. For a "warm closure" they have removed everything. They are keeping a skeleton crew; security, will need to keep the roads plowed. There is interest in the facility. Patricia Montgomery asked what kind of interest; the Supervisor said buy or lease or the State could give it to person/people of interest if it is something "real". The Supervisor stated we are in desperate need of senior housing in Essex County.

Peter Yolles owns a house on Barton Hill and he would like to give it to the Town; it borders Town property. The Supervisor stated if the Board was interested he would look in to it further, they Board was in agreement with this.

The Supervisor received an email from a resident on Bartlett Pond Road, they asked if the Town would consider putting up privacy fencing near the water plant. Councilman Brassard stated it is quite a distance away. The Board was not in agreement with this.

The Supervisor reported the campsite inspections went good. Backflow preventers are still an issue; we were written up on them because campers are removing them; all have been replaced.

WHEREAS, at a meeting of said Town Board duly called and held on July 26, 2022, an Order was duly adopted by it and entered in the minutes specifying the said Town Board would meet to consider the increase and improvement of facilities of Sewer District #1 in said Town at a maximum estimated cost of \$17,300,000, and to hear all persons interested in the subject thereof concerning the same at the Town Hall, in Port Henry, New York, in said Town, on August 11, 2022, at 5:30 o'clock P.M., Prevailing Time; and

WHEREAS, said Order duly certified by the Town Clerk was duly published and posted as required by law; and

WHEREAS, a public hearing was duly held at the time and place set forth in said notice, at which all persons desiring to be heard were duly heard; NOW, THEREFORE, BE IT

ORDERED, by the Town Board of the Town of Moriah, Essex County, New York, as follows:

Section 1. Upon the evidence given at the aforesaid public hearing, it is hereby found and determined that it is in the public interest to make the increase and improvement of the facilities of Sewer District #1, in the Town of Moriah, Essex County, New York, consisting of the replacement, reconstruction and rehabilitation of sewer collection mains, laterals, structures, pump station building, pumps, meters, valves and controls, including original furnishings, equipment, machinery, apparatus, appurtenances, and incidental improvements and expenses in connection therewith, at a maximum estimated cost of \$17,300,000.

Section 2. This Order shall take effect immediately.

WHEREAS, pursuant to the provisions heretofore duly had and taken in accordance with the provisions of Section 202b of the Town Law, and more particularly an Order dated the date hereof, said Town Board has determined it to be in the public interest to improve the facilities of Sewer District #1, in the Town of Moriah, Essex County, New York, at a maximum estimated cost of \$17,300,000; and

WHEREAS, the capital project hereinafter described, as proposed, has been determined to be a Type II Action pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act, which regulations state that Type II Actions will not have any significant adverse impact on the environment; and

RESOLVED, by the Town Board of the Town of Moriah, Essex County, New York, as follows:

Section 1. For the specific object or purpose of paying the cost of the increase and improvement of Sewer District #1, in the Town of Moriah, Essex County, New York, consisting of the replacement, reconstruction and rehabilitation of sewer collection mains, laterals, structures, pump station building, pumps, meters, valves and controls, including original furnishings, equipment, machinery, apparatus, appurtenances, and incidental improvements and expenses in connection therewith, there are hereby authorized to be issued \$17,300,000 bonds of said Town pursuant to the provisions of the Local Finance Law.

Section 2. It is hereby determined that the maximum estimated cost of the aforesaid specific object or purpose is \$17,300,000, which specific object or purpose is hereby authorized at said maximum estimated cost, and that the plan for the financing thereof is by the issuance of the \$17,300,000 bonds of said Town authorized to be issued pursuant to this bond resolution; **PROVIDED**, **HOWEVER**, that to the extent that any grants-in-aid are received for such specific object or purpose or the Town Board shall appropriate other monies of the Town therefor, the amount of bonds to be issued pursuant to this resolution shall be reduced dollar-for-dollar.

Section 3. It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is forty years pursuant to subdivision 4 of paragraph a of Section 11.00 of the Local Finance Law. It is hereby further determined that the maximum maturity of the serial bonds herein authorized will exceed five years.

Section 4. The faith and credit of said Town of Moriah, Essex County, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. To the extent not paid from monies raised from said Sewer District #1 as applicable in the manner provided by law, there shall annually be levied on all the taxable real property of said Town, a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.

Section 5. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the Supervisor, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Supervisor, consistent with the provisions of the Local Finance Law.

Section 6. The powers and duties of advertising such bonds for sale, conducting the sale and awarding the bonds, are hereby delegated to the Supervisor, who shall advertise such bonds for sale, conduct the sale, and award the bonds in such manner as he shall deem best for the interests of said Town, including, but not limited to, the power to sell

said bonds to the New York State Environmental Facilities Corporation; provided, however, that in the exercise of these delegated powers, the Supervisor shall comply fully with the provisions of the Local Finance Law and any order or rule of the State Comptroller applicable to the sale of municipal bonds. The receipt of the Supervisor shall be a full acquittance to the purchaser of such bonds, who shall not be obliged to see to the application of the purchase money.

Section 7. All other matters except as provided herein relating to the serial bonds herein authorized including the date, denominations, maturities and interest payment dates, within the limitations prescribed herein and the manner of execution of the same, including the consolidation with other issues, and also the ability to issue serial bonds with substantially level or declining annual debt service, shall be determined by the Supervisor, the chief fiscal officer of such Town. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law, and shall otherwise be in such form and contain such recitals, in addition to those required by Section 51.00 of the Local Finance Law, as the Supervisor shall determine consistent with the provisions of the Local Finance Law.

Section 8. The Supervisor is hereby further authorized, at the Supervisor's sole discretion, to execute a project finance and/or loan agreement, and any other agreements with the New York State Department of Environmental Conservation and/or the New York State Environmental Facilities Corporation, including amendments thereto, and including any instruments (or amendments thereto) in the effectuation thereof, in order to effect the financing or refinancing of the specific object or purpose described in Section 1 hereof, or a portion thereof, by a bond, and/or note issue of said Town in the event of the sale of same to the New York State Environmental Facilities Corporation.

Section 9. The power to issue and sell notes to the New York State Environmental Facilities Corporation pursuant to Section 169.00 of the Local Finance Law is hereby delegated to the Supervisor. Such notes shall be of such terms, form and contents as may be prescribed by said Supervisor consistent with the provisions of the Local Finance Law.

Section 10. The validity of such bonds and bond anticipation notes may be contested

- 1) Such obligations are authorized for an object or purpose for which said Town is not authorized to expend money, or
- 2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or
- 3) Such obligations are authorized in violation of the provisions of the Constitution.

Section 11. This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150-2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

Section 12. This resolution, which takes effect immediately, shall be published in summary form in the official newspaper, together with a notice of the Town Clerk in substantially the form provided in Section 81.00 of the Local Finance Law.

Discussion: The Supervisor stated we are not borrowing all, it will be done in pieces.

WHEREAS, The Town of Moriah, Essex County, Town Board desires to promote the streamlining of the application process for small-scale photovoltaic system installations under 25 kW in size by adopting the New York State Unified Solar Permit application form and implementing the new procedures,

NOW THEREFORE, BE IT RESOLVED, the Town of Moriah, Essex County, Town Board hereby adopts the New York State Unified Solar Permit application form and procedures for the installation of small scale photovoltaic systems; and it is further

RESOLVED, The Town of Moriah, Essex County, Code Enforcement Officer is hereby directed to use said New York State Unified Solar Permit application for and procedures in the issuance of building permits for the installation of small-scale photovoltaic systems; and it is further
