The Town of Moriah Town Board held their End of Year Meeting on Thursday, December 28, 2023 at 10:00am at the Town of Moriah Town Hall, 38 Park Place, Port Henry, NY.

The Supervisor called the meeting to order at 10:00am by saluting the flag. He read the legal notice calling for the meeting.

The Supervisor stated this is his last board meeting. It has been a privilege working with all of you. He stated we are fortunate to have the employees we have and all the years of experience, thank you everybody! He has been making calls. He thanked Chip Perry; best wastewater treatment plant operator, plant is like a hospital. He thanked Art Morgan; could always count on Art to respond; day or night. He thanked Jamie Wilson; had a lot of back and forth with the Highway Superintendent. The Supervisor reminded Councilman Brassard to stay in his lane when he is the Supervisor; can't micro manage. He thanked Paul Salerno; deputy for 20 years; he quit and came back the same day; they have been friends since they were kids; they have come nose to nose a couple of times and have remained friends. The Supervisor stated he will miss everybody; feels good he is going on his own terms. Councilman Brassard is a good man; have a good town board. He stated Councilman Brassard will learn something new every day if he listens to his constituents. He stated it has been a good ride.

Councilman Salerno stated he worried the Board of Supervisors would take advantage of Councilman Brassard out at the County. The Supervisor stated when Councilman Brassard was elected he was elected for both the Town and the County Board of Supervisors. The Town Board has nothing to do with the County Board of Supervisors. He stated Councilman Brassard has been going to the meetings for the last month and half. Councilman Salerno asked about his vote at the County and the Supervisor stated it is done alphabetically; he stated Moriah, Ticonderoga and North Elba are the largest Town's in the County and the Town of Moriah has the most number of employees that work at the County. The Supervisor stated that Councilman Brassard will do well. The Supervisor said the Board will probably consist of 4 members for a year until elections in November. He stated Councilman Brassard needs to resign as Councilman to the Town Clerk; then there will be an opening. He also said there has been a few times when we have had a 4-man board; he suggests not appointing anyone; let them run. Councilman Salerno asked if votes are tabled or tied what happens and the Supervisor stated the vote fails. The Supervisor stated Roberts Rules are what the Town follows and the Town Clerk will try to get a copy of them. Need 3 votes to pass a resolution.

Councilman Salerno asked about investing with NY Class for a higher interest rate. The Supervisor stated that Glens Falls National Bank meets their rate. The Supervisor stated he always felt putting money in the local bank was best; think about our own Town. Councilman Salerno asked if all of the fund balance was invested and the Supervisor said no. The Supervisor stated the Town is in the best financial shape it has ever been. He cautioned the Board to spend wisely and stay out of debt. He stated we have always done callable bonds because you can pay them off early with no penalty. Councilman Salerno asked if we needed to replace a piece of equipment in 2024 and did not budget for it, how would we pay for it and the Supervisor stated you would have to pass a resolution first and use fund balance. Councilman Brassard stated if we borrow the money we don't have to start paying it back for one year.
