Supervisor Thomas Scozzafava called the meeting to order at 6:00pm.

Special Guest: The Supervisor stated that Jennifer Howard from Stewart's will not be here tonight due to the weather.

Department Head/Town Board Reports:

All Department Heads excused.

Jamie Wilson-Highway Superintendent reported they have been working long hours due to the storm. They have had 400 plus over time hours. The excavator is coming along. Effective January 1, 2020 Leigh Dunning got done as a mechanic and went back to regular HEO. Mr. Wilson stated that he and the Supervisor have met with FEMA; getting estimates together, they will meet with FEMA again on the 21st. Mr. Wilson stated that Cheyenne Morin, Transfer Station Operator has retired. James Cirrincione will be transferring form the Highway Garage to the Transfer Station. There is a gate up in front of the Compactor and there will be one going up by the C & D container and metal container. Fence will be going up around the perimeter in the Spring. The Supervisor stated the gate by the compactor cost @ \$150 and will hold roughly 200lbs; it is for the safety of the employees. The Supervisor also stated that we will see how it goes with a PT person at the Transfer Station. He also stated that we need scales at the Transfer Station. Councilman Brassard stated that anybody in the County can use the Transfer Station. Councilman Anderson asked where do we get scales? Jamie Wilson has been looking in to them; they will be digital. The Supervisor stated that he and Mr. Wilson toured the Ticonderoga Transfer Station; they take stickers or checks and they are getting ready to accept debit cards. He also stated that workers really need to pay attention to what is going in the compactor. Councilman Brassard stated that he has heard good comments about how well the Highway crew did during the storm. The Supervisor reminded everyone that the Town of Moriah has six (6) population centers; it is very difficult to clean up all hamlets immediately after a storm, the Highway Garage does a great job with the man power and equipment that they have; we also had to have the County help out.

The Supervisor stated that he has been getting some complaints about the sidewalks. He reminded everyone that keeping the sidewalks clean on Main Street and part of Broad Street was in the Dissolution Plan; we try to do other areas. The Supervisor reminded everyone that 9N & 22 is a state road and we can't touch it until we get permission from the state to do so. Sharon O'Connor asked if we need permission for every storm and the Supervisor and Mr. Wilson both said yes.

Councilman Salerno read the Water Department Report. They had 7 water breaks; 5 of which they used the vac machine and it worked well and they had 5 sewer plugs. Roughly 283 fire hydrants have been shoveled out between the Building & Grounds Department and the Water & Sewer Department.

Councilman Salerno read the Building Codes report. They issued 2 building permits for the month of January and responded to 1 complaint.

Councilman Salerno then reported on Building & Grounds. He stated that John Aurilio is having an issue with his truck/gas tank; gauge doesn't work. The Supervisor stated that due to our recent audit we have to keep track of odometer readings and the one in John's truck was not working.

Councilman Brassard read the Police Report: Handled 135 calls for service. 0 Violations. 0 Misdemeanors. 0 Felonies. Issued 11 traffic tickets. Handled 9 traffic accidents. Conducted 16 pistol permit background investigations. Conducted 6 background investigations for employment purposes.

Councilman Anderson read the Animal Control Officer's Report: Had 18 complaints since last meeting.

Councilman Anderson reported on the Youth Commission. They have met with Mike Mascarenas at Essex County. They are formalizing youth sports through the Youth Commission. They would like to appoint Julie Anderson to the Youth Commission Board; Beth Trombley got off. The Supervisor stated that people call the Town regarding youth sports because we insure them. Background checks have to be done. He is glad to see that the Youth Commission Board is tightening up the program. Councilman Anderson stated they will formalize and set procedures. The Supervisor reminded everyone to call the Youth Commission first and then the Town Board. Councilman Anderson stated they should have a policy for the next town board meeting and they will also have names for the counselors for the summer program. The Summer Program will be able to use the school this summer but next year we might have to look at BOCES due to the Capital Project the school has going on.

Councilman Salerno reported that the monitor heater at the Museum is old; company went out of business 5 years ago and Building & grounds have been unable to fix it. He would like to recommend a monitor heater similar to the one in the Court House, they run @\$1,800 and Councilman Salerno stated that he would volunteer his time to help Ed Roberts install it. The new monitor would be lp gas. The Supervisor stated he thought it could wait until Spring and Councilman Salerno said yes. Councilman Salerno stated there are 3 modine heaters at the highway garage that aren't working and we should think about replacing at least one of these this year and Mr. Wilson stated they need other things first.

Supervisor's Report:

The Supervisor reported that bids were opened for the Tarbell Hill Pump Station. He has called a special meeting for February 27th, will award bid then. MCJ Construction was low bidder. Engineers are reviewing them now.

The Supervisor received plans from Stewart's on the new building as well as building codes. He stated it is a good location; they are taking the Witherbee mansion into consideration. They will also be here on the 27th to do a presentation.

The Chamber has requested help with parking, cones, etc for August 31, 2020 (Labor Day Celebration). He asked if there was issues with parking last year and Councilman Brassard stated he didn't think so. The Supervisor stated he feels that Bulwagga Bay would be a better location. Jamie Wilson stated they like to use the brook for the boat races. Councilman Brassard will look into the parking situation.

The Supervisor stated the Transfer Station is running \$17,559 in the red. \$8,800 of it is for fill ins when scheduled employees are not there. He feels the \$3.00 per bag drove people to Casella and Ace. Councilman Brassard stated that scales would definitely help. Jamie Wilson stated that Ticonderoga has 3 full time employees. Sharon O'Connor asked how much we get when

someone from outside of the Town of Moriah brings their garbage to the Transfer Station and the Supervisor stated there is no way to know that.

The Supervisor reported that some residents have approached Councilman Salerno regarding the historic sign in front of Mac's. Historian Betty Lamoria gave a list of all historical markers to the Supervisor that are in the Town. There is a program to replace the markers. They cost @\$1,200 apiece. The Supervisor stated maybe the Town could afford to do one or two a year. He will bring this up during budget time.

The Supervisor reported that Mark Davenport has resigned from the Waterfront Committee. If anyone is interested in that seat they should contact the Waterfront Committee and then they can bring the name before the Board. He thanked Mr. Davenport for his service.
