Special Guests: Matt Courtright and Carol Calabrese: 2026 Moriah Microenterprise Grant Program

The Supervisor stated that he, Councilman Curran and Carol Chiarella have resurrected the Economic Development Committee and they met with Carol Calabrese-Essex County IDA and Matt Courtright-Ticonderoga Area Chamber of Commerce regarding using some of the bed tax money the Town receives for micro grants for small businesses. Ms. Calabrese stated the IDA has done 11 of these micro grants. They are to assist small businesses; has to be tourism related. Ms. Calabrese went over the definition of a small business. Mr. Courtright stated there is less requirements with this type of grant but there is mandatory training/class. Ms. Calabrese stated the business will have 2 weeks to complete the application. Mr. Courtright stated the business can schedule an appointment with them to help get started. Ms. Calabrese stated after the application is completed there is a 2 week turn around time; it will go before the grant committee. The Board needs to pass the resolution for these small grants and the IDA will monitor for 1 year. Mr. Courtright stated the Economic Development Committee needs to meet and set aside the amount of bed tax money they want to use. The Supervisor stated the Town receives \$80,000 in bed tax money; currently helps the Chamber, musical festival, etc.

WHEREAS, the Federal Emergency Management Agency (FEMA) has completed a flood hazard study for Essex County and provided the Town of Moriah with updated Flood Insurance Rate Maps (FIRMs) and a Flood Insurance Study (FIS) report that delineates the Special Flood Hazard Areas (SFHAs) and flood risk zones for the jurisdiction; and

WHEREAS, the updated FIRM and FIS report are based on current, scientific, and technical data and are intended to replace the previously issued maps to ensure accurate and consistent identification of flood-prone areas; and

WHEREAS, FEMA requires communities participating in the National Flood Insurance Program (NFIP) to adopt the revised FIRM and FIS report in order to remain in good standing with the program and ensure continued eligibility for federally backed flood insurance; and

WHEREAS, the Town of Moriah has reviewed the updated FIRM and FIS report and finds them acceptable and beneficial for local floodplain management, hazard mitigation planning, and community resilience;

NOW, THEREFORE, BE IT RESOLVED by the Town Board of the Town of Moriah, that:

- 1. The Town of Moriah hereby accepts and adopts the revised Flood Insurance Rate Map (FIRM) and Flood Insurance Study (FIS) report issued by FEMA for Essex County, effective July 17, 2025.
- 2. The Town Board of the Town of Moriah is authorized and directed to ensure implementation of the updated maps in accordance with the requirements of the National Flood Insurance Program and applicable local regulations.
- 3. This Resolution shall take effect immediately upon adoption.

Discussion: The Supervisor stated about a year ago the DEC updated the flood plane maps; we need to adopt this or we won't get any FEMA money in the future if we have an emergency.

RESOLVED In the Matter of the Granting of a Cable Television Franchise Held by Spectrum Northeast, LLC in the Town of Moriah, County of Essex, New York,

an application has been duly made to the Board of the Town of Moriah, County of Essex, New York, by Spectrum Northeast, LLC, an indirect subsidiary of Charter Communications, Inc. ("Charter"), a limited liability company organized and existing in good standing under the laws of State of Delaware doing business at 2604 Seneca Avenue, Niagara Falls, NY 14305, for the approval of a renewal agreement for Charter's cable television franchise for fifteen (15) years commencing with the date of approval by the Public Service Commission.

The franchise renewal agreement would bring the franchise into conformity with certain provisions of the Federal Cable Communications Policy Act of 1984, as amended, and certain court rulings.

A public hearing was held in the Town of Moriah, New York on Thursday, July 17, 2025 at 5:45P.M. and notice of the hearing was published in the Press Republican on July 9, 2025.

NOW, THEREFORE, the Board of the Town of Moriah finds that:

1. Spectrum Northeast, LLC has substantially complied with the material terms and conditions of its existing franchise and with applicable law; and

- 2. Spectrum Northeast, LLC has the financial, legal and technical ability to provide these services, facilities and equipment as set forth in its proposal attached; and
- 3. Spectrum Northeast, LLC can reasonably meet the future cable-related community needs and interests, taking into account the cost of meeting such needs and interests.

BE IT FURTHER RESOLVED that the Board of the Town of Moriah hereby grants the cable television franchise of Spectrum Northeast, LLC and the Town of Moriah for fifteen (15) years commencing with the date of approval by the Public Service Commission and expiring fifteen (15) years hence.

BE IT FURTHER RESOLVED that the Board of the Town of Moriah hereby confirms acceptance of this franchise renewal agreement.
