LOCAL LAW NO. 4 OF THE YEAR 2002

A local law providing for penalties for fishing violations at Roe Pond in the Town of Moriah, County of Essex and State of New York.

Whereas Roe Pond has been designated as a Children's Pond since the pond is accessible to any child in the Town of Moriah, County of Essex and State of New York.

Whereas individuals confined to wheel chairs would also be allowed to fish at Roe Pond and they are invited to do so.

Whereas parents with a child or children are encouraged to teach their children how to fish; Roe Pond has been designated as a children's pond.

SECTION 1. Title. This local law shall be known as fishing violation at children's Pond, also known as Roe Pond in the Town of Moriah, County of Essex and State of New York.

SECTION 2. Definitions. Children's fishing shall include children up to and including the age of 15 years and also including individuals confined to wheel chairs.

SECTION 3.

Penalties The violation fines are as follows:

First Violation \$50.00 to \$100.00

Second Violation \$100.00 to \$250.00

Third Violation \$250.00 to \$500.00

This local law shall take effect immediately upon filing with the office of the Secretary of State.
