The Supervisor stated he got a thank you card from Cheyenne Morin.

He also reported that the State of Emergency will be extended through June 15, 2020.

The Supervisor reported that the Town Hall is open again. We have a plan in place. One person is allowed in at a time and they must have a mask on.

All crews are back up and running; following all social distancing guidelines.

The Supervisor stated that the Essex County Treasurer's Office will not do any foreclosures for 2020 due to COVID 19 hardships.

The Supervisor stated he has had some concerns regarding travel trailers being set up on property; Rice Street being one of them. In the Town of Moriah's Local Law regarding mobile homes there is a \$20.00 permit fee. If you have 2 or more travel trailers, then it becomes an issue with the NYS department of Health; they consider that a campsite. The Supervisor spoke to Codes and they all feel that NYS should handle it. Councilman Salerno asked if you had to pay debt service for a travel trailer. The Supervisor stated everybody has to pay debt service if they are in the district. Councilman Salerno asked if there was more than one trailer would there be more than one debt service charge and the Supervisor said no, not for RV's.

The Supervisor reported that recycling will start up again tomorrow.

The Supervisor stated that the campsites will be opening June 6th. The Managers will arrive a week early. The work crews were back on Monday. The Supervisor stated he has been down there and it looks good. Water and power are on. There will be reduced rates due to the late opening. No transients are allowed at this time. The Supervisor is looking in to this, if they have a self-contained there shouldn't be a problem. He is wondering if NYS will open their campsites June 1st. He said it is crazy, rules are changing daily; for an example you can play tennis but not pickle ball. The Supervisor said he is taking it one day at a time. He is not sure if the beaches will be open. Waiting to see what Governor Cuomo says. Councilman Salerno asked if Linda Beers could do anything and the Supervisor said no.

The Supervisor stated that we are at about 38% response for the Census. He asks that you please fill it out. It is critical for grant money, and senatorial and congressional districts as far as voting. You are only harming the Town if you don't fill it out. Councilman Salerno asked if there was a penalty for not filling it out and the Supervisor said the penalty would be to the Town, the School and the County. Councilman Brassard stated that the census workers are not going door to door.

The Supervisor stated that there is County COVID 19 testing available. More tests are a good thing; brings you to the next reopening phase quicker. Testing locations are as follows: Elizabethtown Community Hospital; 518-873-3069; Daily by appointment; 10:00am – 2:00PM and Elizabethtown Community Hospital-Ticonderoga Campus; 518-585-3927; Daily by appointment; 10:00AM – 2:00PM.

WHEREAS, the Town Board of the Town of Moriah, Essex County, New York, has caused to be prepared a map, plan and report, including an estimate of cost, pursuant to Section 202-b of the Town Law, relating to the increase and improvement of the facilities of the Sewer District No. 1 in the Town of Moriah, Essex County, New York (the "Sewer District"), being the reconstruction of the Tarbell Hill Pump Station, and master sewer district preliminary planning for other projects in and for Sewer District No. 1, including original furnishings, equipment, machinery, apparatus, appurtenances, and incidental improvements and expenses in connection therewith, at a maximum estimated cost of \$300,000; and

WHEREAS, said capital project has been determined to be a "Type II Action" pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act ("SEQRA"), the implementation of which as proposed, such regulations provide will not result in any significant adverse environmental impact; and

WHEREAS, it is now desired to call a public hearing on the question of the increase and improvement of the facilities of said Sewer District, in the matter described above, and to hear all persons interested in the subject thereof, concerning the same, in accordance with the provisions of Section 202-b of the Town Law; NOW, THEREFORE, IT IS HEREBY

ORDERED, by the Town Board of the Town of Moriah, Essex County, New York, as follows:

<u>Section 1</u>.
