The Supervisor opened the meeting at 6:00pm by saluting the flag. He thanked everyone for coming.

Department Head/Town Board Reports:

The Supervisor reported that Building & Grounds have been busy putting up the farmers market banner; mowing & weed whacking; they are down a mower; getting cemeteries ready for Memorial Day; getting 3 quotes for mold removal at the Iron Center Museum. Councilman Salerno asked if that will be covered under the Town's insurance and the Supervisor stated the Town Clerk has already gotten a hold of the insurance and they are sending an Engineer to look at it.

Councilman Salerno stated the campsites are off to a good start. 168 seasonals at Bulwagga Bay Campsite; garbage stickers are up; transients are up; cabins are already being rented. Neal Larkin has been doing a good job. Bill Cook, Manager at Champ RV Park stated there are 68 seasonals; up from last year.

Councilman Salerno reported the Water & Sewer Department has been dealing with a lot of water and sewer breaks; the new machine is paying for itself.

Councilman Salerno stated he has no police report.

Discussion: Councilman Anderson stated they are all good kids. It is getting harder and harder to compete with Camp Dudley and what they pay. Will be able to handle 150 kids; we usually get around 100 per day.

Councilman Anderson stated there is a youth board meeting tomorrow night; Counselor's will need training. The Supervisor stated he got an email from Dee Olcott, Bouquet Valley is looking for Counselor's for their summer program if anybody knows a child who is still looking for employment.

Councilman Gilbo had nothing to report.

Councilman Curran reported they are working on a community garden down at the train station. The Supervisor stated the seniors go down there for lunch and dinner meals they could grab some fresh veggies while they are there.

Councilman Salerno stated the lake water is very high at Bulwagga Bay Campground between the point and the brook; there are 17 campers that it is affecting. The Supervisor stated we received a \$50,000 engineering grant for this issue; it will start this summer; Beth Gilles Lake Champlain Lake George Regional Planning Board will go after money for the project. Councilman Salerno wondered if now or the Fall is the best time to start this project and the Supervisor stated we are currently at a medium/high level. Councilman Anderson asked about the Core of Engineers and the Supervisor stated he thought it was 2013 the last time they were here. Councilman Salerno suggested a berm; he stated we definitely need to look in to it. Councilman Gilbo suggested big rocks to slow the water down. Councilman Salerno stated he wanted to mention it because we need to start thinking about a plan.

Supervisor's Report:

The Supervisor reported that the YCC Program will run same dates as the Summer Program; 7/7/25-8/1/25; you have to be 14 years old and have a working card; you can get the working card at the school. Applications are available at the Town Hall and the School.

The Supervisor stated Moriah had a rabies clinic on May 14th, had 187 people registered and 178 people showed up; good turnout.

The Town Clerk stated we only have 133 dogs registered in the Town of Moriah; a lot of people think they only have to do it once but it is done yearly. The Supervisor stated it is very helpful for the dog catcher if a dog is running loose or lost to find the owner. Councilman Gilbo asked if it was a Town law and the Town Clerk stated no, it is a state law. Once the Town Clerk has an idea how much it is going to cost she will let the Board know.

The Supervisor stated the NYS Department of Health will have to do a walkthrough of the new cabin at Bulwagga Bay before renting; it is already rented 20 of the 31 days in July. The Supervisor asked the Board what they wanted to charge for it; current cabins get \$100 for Friday and Saturday and \$90.00 for Sunday – Thursday.

RESOLVED to charge \$150.00 for Friday and Saturday night and \$130.00 Sunday – Thursday for the new cabin at Bulwagga Bay Campsite; minimum 2-night stay.

Floor Open to the Public:

Paul Tromblee asked the Supervisor about the ambulance deal, is the Town going to form a district. Mr. Tromblee stated we need to get rid of these people, too much controversy, don't need those people in our Town. The Department of Health mandates you only need one EMT on the ambulance. We need to look at hiring young people who want to be EMT's. The Supervisor stated they are not Town employees; if they were there would be unions, retirements like in the big cities; it would be a much bigger cost. Mr. Tromblee stated there are 38,000 residents in the County; 50% are on fixed incomes; it all trickles down to the communities. Mr. Tromblee wants the Board to control the ambulance squad; he feels there should be more investigation. The Supervisor stated the Comptroller is involved. Mr. Tromblee stated "I will shoot every one of them" he doesn't know how Billy feels but there has been a lot of time and effort put in to building the squad, became a critical care unit. Mr. Tromblee stated the ambulances are not theirs, they belong to the local people. Mr. Tromblee stated he supports the Town Board 100%. He stated people are saying the same thing, they want locals to handle it. Nancy Tromblee asked if there were any bylaws regarding the equipment, she asked if they can just take it and the Supervisor stated too much has changed, it is a private company now; they have their own Board of Directors. Mr. Tromblee stated when he was in the ambulance squad they had 25 members and had a core group of 12-15 that they could depend on; day or night and they never asked for anything. The Supervisor stated just gas and worker's compensation. Nancy Tromblee asked again do the ambulances belong to them and the Supervisor stated legally it would be a tough, he stated the Town Attorney is looking in to it. Paul Tromblee asked if the Town was stuck with them for the rest of the year and the Supervisor said yes, through 2025 and then it would be a Board decision what happens in 2026; definitely looking at a district. Paul Tromblee stated a lot of people in Town are PO'd. Councilman Salerno stated the Essex County grant opened up a can of worms; volunteers went bye bye. The Supervisor stated Moriah is 1 of 6 towns dealing with this problem. Paul Tromblee stated the County EMS never should have happened; they should have supported the Town EMS. Councilman Salerno asked if a district would be assessed value of the home and the Supervisor stated it could be set up anyway we want. Councilman Salerno stated if it is based on parcels a resident could end up paying \$6,000 compared to \$150; he feels that is not fair. Paul Tromblee stated the Town should have the right to say how the squad functions.

Paul Tromblee asked if the Highway Garage had enough manpower now and the Supervisor stated we are still down 1 guy. Mr. Tromblee stated construction pays too much; they get the workers.

The Supervisor stated 4 wheelers and dirt bikes are out again; he wants to remind everyone that we have a 1-man police department; he asked parents to please ask your children to be respectful when they are riding.

The meeting adjourned at 6:57pm.
