Department Head/Town Board Reports:

Rich Lapier-Building Codes: Report provided. Issued 3 building permits for the month of September. Had one complaint for sewage which has been resolved.

Jamie Wilson had nothing to report.

Councilman Anderson had nothing to report. There is nothing going on with the Youth Commission.

Councilman Brassard reported that the police car has been at Sleeper's Garage for some repairs; the window is done but are still working on the traction control. He also reported that the Transfer Station is running well. They put new windows in the power building. The free dump day is going well.

Supervisor Scozzafava stated there will be a price increase for C & D at the Transfer Station. We will be collecting C & D every day. Jamie Wilson stated we will need a 2nd C & D container. The Supervisor asked if we can get a spare one and Mr. Wilson said if they can supply one. He

also stated that we have not had to turn anyone away for lack of room in the C & D container. The Supervisor stated accepting C & D every day and not closing for lunch will help also. Mr. Wilson stated that the metal container is filling up every 5-6 days. Councilman Anderson stated that C & D is busy during the summer. Councilman Brassard stated he had somebody ask him if a dishwasher was free, Mr. Wilson stated yes, it is metal.

Supervisor's Report:

The NYS Police Reform needs to be complete by April 2021. The Sheriff is working on a template. The Supervisor will appoint two Councilman to work on this and we will also need a Citizen's committee to work on it. Next year we will only have one full time police officer. We will need more than one officer to keep the department running. The Supervisor is not sure if the Sheriff's Department will be able to offer more patrol or if the NYS Police will have a satellite station here. Councilman Brassard asked if the citizen's committee will be put in the paper. The Supervisor stated we will wait until we get the template from the Sheriff.

The Supervisor stated he has received some guidance from NYS Department of Health regarding Trick or Treat. The County is also working on some guidelines. He stated the Board does not want to cancel trick or treat. He stated there is a \$10,000 fine for not following COVID 19 orders but we do not have the resources to police it. The Supervisor stated that he and the Board are under pressure daily due to COVID 19. Councilman Anderson asked what our options are for Halloween. The Supervisor stated that the Governor is not stopping trick or treating. The Supervisor has faith in people not to go to someone who doesn't want to hand out candy this year. He feels people will use some common sense.

The New York State Department of Taxation and Finance issued a STAR Delinquency Report. It lists any STAR exemption recipient whose property taxes are more than one year delinquent, will lose their STAR exemption. The Town has nothing to do with this decision.

The Supervisor stated he has an interested buyer in the building the Port Henry Fire Department is in. There will be a clause in the sale that states the department will be allowed a certain length of time to stay until they find a different building. He will have more information at the next meeting.

The Supervisor has had a request from the Women's League of Voters to put voting signs up at the Town Hall. We have a policy in place there will be no political signs at the Town Hall. He asked the Board if they wanted to allow these signs; they are not political; they just state the three different ways to vote. Councilman Anderson and Councilman Brassard had no problem with it.

Canadian Pacific is finally ready to start the roof on the Train Station but are now waiting for the parking lot project to finish up so they can start.

The solar energy project on Decker's Flats; west side; Zelinski property is ready to start and there are certain things the Supervisor and Town Board have to do. We need a pilot agreement. Councilman Gilbo is working on it. We need this agreement in order for them to pay in lieu of taxes.

The Town needs to adopt a Public Health Emergency Plan. The County is working on a boiler plate for all Town's in Essex County to use.
