The Supervisor called the meeting to order at 6:00pm by saluting the flag.

Mr. Wilson suggested that the Board not accept the bid on the paver; he thinks it is worth much more than that.

Floor Open to the Public: No one spoke.

# **Department Head Reports:**

Jamie Wilson, Highway Supt., reported that the water project for Water District #4 is almost complete; they are wrapping up on the next phase. Soon they will be milling and paving. Mr. Scozzafava stated that they had a meeting Wednesday morning regarding the paving on this project. Under the contract there was to be the one lane paved with binder and top. It was decided that it makes more sense to pave the whole road rather than just one lane; we will use the money budgeted for paving roads this year. We are getting a quote from the subcontractor for the paving as they already in the area. Mr. Scozzafava spoke with the Comptroller and because there is a substantial change in the contract, the only way we can do it is to do a change order at no markup and the Town pays their portion. When it is done the roads will be milled with a layer of binder and then the top layer. The increase will be \$112,218 based on the quote provided to the Town Highway Superintendant.

**RESOLVED** that the Town of Moriah Town Board approve the Change Order for Water District #4 to provide additional asphalt pavement milling and asphalt pavement binder for the second lane of traffic at unit price rated found in the current Contract. Any services provided by the Town of Moriah Highway Department will be deducted from the Contract upon completion of the work. Work to be paid for out of the existing Contract Allowance. Estimated price increase of \$112,218 based upon the quote provided to Town of Moriah Highway Superintendent.

This will be the highway department's main project this year using the CHIPS money. Spoke with the Supervisor regarding money to do Grover Hills; we can try to get a grant from HUD to do the roads there, but it doesn't look promising. We may have to Bond the project to get it done. Mr. Wilson will come back with figures as to what the cost to do all of Grover Hills would be.

The highway has been working at the beach trying to put it back together; we are losing the shoreline. The Board discussed the shoreline erosion and what to do next.

Richard LaPier, Building Codes Officer, gave the following report: he issued 11 building permits in May, issued two violation notices for property maintenance codes and did three safety inspections on area businesses.

Mr. Scozzafava stated that he gets calls all the time on property clean up; the notices of violations are on file at the town hall. It is difficult to get people to clean up. We should get laws from the Department of State to draft our laws from. Bank foreclosures on property are another issue.

Building & Grounds and Dwayne have been excused.

Councilman Carpenter gave the following police report: the Police Department handled 181 calls of service in May of which four were violation arrest, six misdemeanor arrests, issued 15 traffic tickets and investigated five traffic accidents.

#### **Town Board General Discussion:**

Mr. Scozzafava stated that he and Becky will start the budget process sometime I August this year.

### **Town Board Committee Reports:**

Councilman Salerno stated that the campsite had a good Memorial weekend. The campsite is almost full with 163 out of 165 seasonal sites filled.

Councilman Garrison reported that the Chamber/EDGe meeting will be next Thursday at 6:00pm at the Courthouse. The Iron Ore man went well even though it was pouring rain. The Johnny Podres sign event went well and we hope to draw a lot of tourist. Councilman Anderson stated the hike went well and hopes it will be an annual event. Mr. Garrison stated they are talking of doing the event again on Labor Day weekend. Mt. Lakes PBS and Adirondack Trail are doing stories on the event. The Board discussed the need to move the trailhead to the old landfill. Mr. Wilson stated his department cuts the grass at the old landfill around the fourth of July every year so it doesn't grow up. We received the final monitoring report on the landfill and everything is good.

Councilman Anderson stated the Summer Program is ready to start July 9<sup>th</sup> and will run through August 9<sup>th</sup> with the last day slated for cleanup. The program will b at MCS and the food program and personnel are in place.

Mr. Anderson stated that there will be no pool at the school, but they will be taking the kids to the beach for four days. We will need to hire an aquatic instructor at an hourly wage even though there are three lifeguards there.

Councilman Carpenter met with Chris Lobdell at the school regarding Channel 17. The reason the board meetings hadn't been on was a problem with the router. The board discussed channel 17 and said it is not being utilized enough. Mr. Carpenter stated that Mr. Lobdell was never trained on the equipment and suggested getting him some training.

Mr. Carpenter asked if a decision has been made on junk day. Mr. Scozzafava just has to call Serkil a week ahead of time to get a couple of dumpsters; we need to set the dates and let them know. This will be just for junk and people won't be able to bring C&D those weekends as the dumpsters will be set up in that spot. This will be for junk only, no garbage. Have heard from some people and they think it's a great idea and way to clean up the Town. Some people are concerned that they have no way of getting it to the transfer station; maybe neighbors can help out. Mr. Salerno asked for two days for each hamlet. If the Board agrees we can set up Friday and Saturday of those weeks and if it works we will do again in September. People will have to show proof of residency if they are not known to the attendants. We need to get the dates set and sign up there will be no C&D those tow days.

## Supervisor's Report:

- Received notification form NYS DOT that they will be replacing the bridge by Vic's. Alternating one-way traffic will be allowed through the work zone using a temporary traffic signal.
- We have had signs deface throughout the town; this is against the law and carries a fine of \$500.00. Signs are expensive and the police will be on the lookout.
- Received a letter from campers that would like to camp at Bulwagga, but we don't have WiFi. Mr. Garrison is checking into getting WiFi to the campsite.
- Received a letter form the Lake Champlain Bible Fellowship Church stating they have a mission team coming this summer and they will be doing small jobs around the community for the elderly and people who have no means of doing the work themselves. The information will be at the Town Hall if interested. They are also having a free barbecue for the community on July 26<sup>th</sup> at 6:00pm.
- Had a sewer back up at a residence caused by a broken tile that plugged the line. It backed up into the home making a huge mess; they were denied by their insurance and we turned into our insurance and they also denied them (because we have a local law on file requiring a back flow preventer). They are now suing the Town. The insurance company is providing an attorney to represent us (they should've paid the claim, probably cheaper) we need to make the Local Law more public; need to put a notice in with the sewer bills next year.
- The electronic recycling at the transfer station is going very well.
- Talked with Dock Doctors today, they won the bid at the campsite, but have not installed the docks yet. If they are not there next week Mr. Scozzafava suggested we pull the bid. Mr. Salerno suggested speaking with an attorney first.
- There will be first aid training at MCS June 25<sup>th</sup>.
