TOWN OF MORIAH

LOCAL LAW NO. 1 OF THE YEAR 2010

A local law to increase the number of Board of Assessment Review Members from three (3) to five (5).

Be it enacted by the Town Board of the Town of Moriah.

SECTION 1. The Town of Moriah Board of Assessment Review shall consist of five (5) members, who shall be appointed by the Town Board for specific terms of five (5) years, said terms to expire in succeeding years.

SECTION 2. There shall be created, to comply with Section I, herein, two (2) new office who terms shall be as follows:

- A. October 2010 thru September 2015
- B. October 2010 thru September, 2011

The existing offices where terms shall continue shall be as follows:

- C. October 2008 thru September 2013.
- D. October 2009 thru September 2014.
- E. December 2009 thru September 2012

This local law shall become effective immediately upon filing with the Department of State.
