The Town of Moriah Town Board held their End of Year Meeting on Wednesday, December 30, 2020 at 10:00am at the Town of Moriah Court House 42 Park Place, Port Henry, NY.

The Supervisor called the meeting to order at 10:00am by saluting the flag. He stated that the year 2020 has come to an end; he is hoping that 2021 is better. He encouraged everyone to keep practicing social distancing and wearing a mask to stay safe.

Department Head Reports:

Town Board Reports:

Councilman Salerno stated that 2 modine heaters at the highway garage will be coming down. Avery Energy will come next week to begin work on the new ones.

Councilman Anderson stated the Board voted to have the Transfer Station open through lunch; when will that begin. The Supervisor stated January 1st.

Supervisor's Report:

The Supervisor stated that the new highway truck was delivered. Will be used on secondary roads in Port Henry; it is all paid for. The old crew cab will be moved to the Campsites next year.

The Supervisor reported that the Town needs to adopt COVID guidelines. He clarified some confusion regarding employees who are in quarantine. If you come in contact with someone who is in quarantine you are fine; if you come in contact with someone who is positive, then you must quarantine. The County has agreed to help out the Highway Department in case they are down in staff due to anybody who is in quarantine. Councilman Salerno asked what an employee should do if their Supervisor tells them to stay home and quarantine and the Supervisor said to stay home until they hear from Public Health regarding quarantine-will use COVID time for this.

The Supervisor discussed the Police Department. Officer Stahl will be retiring sometime in April 2021. Councilman Anderson is working on a plan. Councilman Brassard stated we need to advertise for a committee and the Supervisor said no we don't, we just need to find people to be on the committee. The Supervisor stated there are a lot of guidelines; it is geared for larger communities. He stated that replacing Officer Stahl will be very difficult; he would like to find a couple of part time people. The Supervisor stated he has started some discussion with the State Police; keeping Officer Brassard on and opening up a satellite office in the Town of Moriah; most likely in Port Henry; they could use the old Village garage to store a vehicle. They need support from the Town Board to go any further. Councilman Anderson stated it is a good idea; worth looking in to. He agreed that it is going to be difficult to find people. He asked if we would hire someone local to be a part time cop and the Supervisor stated it would be very expensive to train someone new. Councilman Salerno asked if it was already in the 2021 budget for 2 40 hour per week people and the Supervisor said yes. Councilman Salerno then asked if we would look for 2 part time people at 20 hours per week and the Supervisor stated he would like to hire 3 part time people but it is going to extremely difficult to find. The Supervisor stated he feels the Town needs some kind of police presence. He asked if the Board supported this and they did.

The Supervisor stated he had assigned Councilman Gilbo the job of looking for someone to build the Town a campsite website. He found a company out of Albany; the website would be for both campgrounds. The cost would be \$2,600; hopefully it would be up and running by February or

March. Councilman Salerno asked if it would be combined with the Town website and the Supervisor stated no, only for the campgrounds right now.
