RESOLVED the increase and improvement of the facilities of Sewer District #1, in the Town of Moriah, Essex County, New York.

WHEREAS, the Town Board of the Town of Moriah, Essex County, New York, has caused to be prepared a map, plan and report, including an estimate of cost, pursuant to Section 202-b of the Town Law, relating to the increase and improvement of the facilities of Sewer District #1, in the Town of Moriah, Essex County, New York (the "Sewer District"), being the replacement, reconstruction and rehabilitation of sewer collection mains, laterals, structures, pump station building, pumps, meters, valves and controls, including original furnishings, equipment, machinery, apparatus, appurtenances, and incidental improvements and expenses in connection therewith, at a maximum estimated cost of \$17,300,000; and WHEREAS, the capital project hereinafter described, as proposed, has been determined to be a Type II Action pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act, which regulations state that Type II Actions will not have any significant adverse impact on the environment; and

WHEREAS, it is now desired to call a public hearing on the question of the increase and improvement of the facilities of said Sewer District, in the matter described above, and to hear all persons interested in the subject thereof, concerning the same, in accordance with the provisions of Section 202b of the Town Law; NOW, THEREFORE, IT IS HEREBY

ORDERED, by the Town Board of the Town of Moriah, Essex County, New York, as follows:

Section 1. A public hearing will be held at the Town of Moriah Court House, 42 Park Place, in Port Henry, New York, on Thursday, August 11, 2022, at 5:30P.M., Prevailing Time, on the question of the increase and improvement of the facilities of Sewer District #1, in the Town of Moriah, Essex County, New York, in the manner described in the preambles hereof, and to hear all persons interested in the subject thereof, concerning the same, and to take such action thereon as is required or authorized by law.

Section 2. The Town Clerk is hereby authorized and directed to cause a copy of the Notice of Public Hearing hereinafter provided to be published once in the official newspaper, and also to cause a copy thereof to be posted on the sign board of the Town, such publication and posting to be made not less than ten, nor more than twenty, days before the date designated for the hearing.

Section 3. The notice of public hearing shall be in substantially the form attached hereto as Exhibit A and hereby made a part hereof.

Section 4. This Order shall take effect immediately.
